### Welcome from chair

Meghan Gallacher MSP welcomed members of the CPG to the first meeting of the new parliamentary term. Meghan informed the group that the meeting would focus on the United Nations of Childrens Rights Convention (UNCRC) Incorporation Bill.

Meghan gave a brief introduction to the UNCRC Incorporation Bill, highlighting the journey it has had from being passed in Scottish Parliament at stage three, to being legally challenged by the UK Government and the Supreme Court.

She informed members that they would hear from those working directly with the Bill and learn what the revised Bill could mean for children and young people and those who work on their behalf.

Following this, Meghan said the members would have the opportunity for more indepth discussion on the UNCRC Incorporation Bill.

Members were informed that the information shared by all members would be collated to create a summary to send paper that would be sent to the Equalities, Human Rights and Civil Justice Committee. Members were also given the option to feedback through a survey that the secretariat sent out before the meeting.

Meghan ran through a range of housekeeping measures before moving onto official business.

Meghan passed over to Parisa Shirazi from Children in Scotland to discuss previous minutes and new members wanting to join.

Parisa then passed back to Meghan who briefly introduced and handed over to the speakers to share their experiences of working with the UNCRC Incorporation Bill.

# Liz Levy, Scottish Government UNCRC Incorporation Bill Team

Liz is Joint Unit Head for the Children's Rights Unit (Scottish Government) who are working on the UNCRC Incorporation Bill.

Liz highlighted the 4 provisions which were identified as being out with Scottish Parliament powers:

- Section 6: Compatibility duty
- Section 19: Interpretation duty
- Section 20: Strike down power
- Section 21: Incompatibility declarator power

She went on to give an overview of the amendments that had been done since the Supreme Court judgement and the communication with the UK Government lawyers – who could not guarantee there would not be another referral to the Supreme Court. She stated the Scottish Bill Team carried out stakeholder engagement to ensure those who lobbied for the Bill understood the changes.

After the engagement work, they decided the most effective route forward was to choose the option which minimised the risk of another Supreme Court referral. The revised Bill would not have the coverage that was originally planned but it was the option that would provide the best coverage for children's rights possible.

Liz also stated Shirley-Ann Sommerville, Cabinet Secretary for Social Justice, was looking to hear from stakeholders and extended an invite to CPG members to contact her.

### Juliet Harris, Director of Together Scotland

Together is an alliance of Scottish children's charities that works to improve the awareness, understanding and implementation of the United Nations Convention on the Rights of the Child (UNCRC). They do this by promoting the UNCRC, helpings children's organisations to integrate the UNCRC into their work, and by monitoring and reporting on the progress made at a Scottish and UK level.

Juliet gave some context on UNCRC incorporation by highlighting countries that had already signed up to incorporating the UNCRC into law. She stated that although the Bill does not cover as much as initially was wished for due to devolution, it is still a good starting point and the beginning of the journey.

Juliet highlighted asks from Ministers:

- Commitment for funding to continue past 2024 for the UNCRC Implementation Programme
- A clear time scale of the review and subsequent action key pieces of legislation being brought in

### Olivia Brown MSYP, Scottish Youth Parliament

Olivia is a Member of the Scottish Youth Parliament for Midlothian North and Musselburgh.

Olivia highlighted that children and young people's rights are at the mercy of adults. She agreed with Juliet's point regarding the UNCRC Incorporation Bill in its new form still being a positive step for Scotland. Olivia stressed that challenges are not as excuse to be less though, and ministers needed to adapt and change to ensure the UNCRC can be incorporated as well as possible.

She highlighted 4 requirements for the UNCRC:

- Cultural change Scotland needs educated on how to uphold the UNCRC in daily life
- 2. Must have children and young people friendly communications all communications must be respectful of the values of the Bill
- 3. Parliament needed to implement the UNCRC to the full extent
- 4. Parliament must act with urgency

### **Group Discussion Summary**

Afterwards, Meghan and Pam gave some brief reflections of the information shared. They extended an invite for members to contact the Equalities, Human Rights and Civil Justice Committee which they both sit on, to share any views on ways to improve the Bill.

After this, Meghan and Pam left the meeting to attend an emergency meeting on the unfolding events in Gaza. Meghan passed over to Sarah Paterson from YouthLink Scotland to chair the rest of the meeting.

Sarah gave the group the opportunity to share thoughts on what they had heard. The main points raised were as follows:

- Members expressed their hope for the beginning of a cultural change with a more intersectional approach – people need to know how to include the voices of children and young people
- Members highlighted the need to question what children and young people voices are already reflected to ensure the voices of minority groups are heard and reflected
- One member suggested the Scottish Government and parliamentarians could engage with children and young people by inviting them into parliament to make them feel their inputs were valued
- Many hoped that minority voices would be heard the loudest
- One member highlighted the importance of universities to be raising awareness of the UNCRC and its issues by making sure the UNCRC is incorporated in educational programmes
- Members agrees that awareness campaigns and resources must be accessible for people about the UNCRC – otherwise it is difficult for people to implement it in everyday life
- Children and young people need to be educated on their rights this should involve peer education with young people teaches others
- The Bill may not account for situations that lead to kinship care
- Parents and adults need to be taught about ensuring children and young people can access rights – adults are
- Some referred to the UNICEF Rights respecting schools and utilising best practise and what already exists. However, some warned of the danger of measuring success by numbers. Rights respecting schools introduces UNCRC to schools but what it doesn't do is affect culture change
- Voices of babies, pre-verbal and nonverbal children and young people still need to be understood.
- Members agreed that the CPG should involve more children and young people going forward
- One member highlighted how the Bill might not account for unique circumstances that lead to kinship care. Although important for the UNCRC to protect children's rights, the UNCRC could introduce legal complexities in some cases and that a one-size-fits-all approach will not be suitable in these cases

### Close

Sarah thanked all attendees for attending and sharing their thoughts. She advised the next meeting of the CPG would be in December.

Following the meeting, it was agreed that a summary paper would be created from the information shared at the meeting and from the survey that the secretariat had sent out prior to the meeting. The summary report would be shared with the Equalities, Human Rights and Civil Justice Committee.

Sarah also advised that the notes would also be shared with Juliet Harris who was giving evidence to the committee on 31st October 2023.

Finally, Sarah told members that the secretariat would be sharing details of campaigns that CPG members had requested were shared with the group.

### Flexible Childcare Services Scotland - Caerus Tool

For the past few years, the team at Flexible Childcare Services Scotland have been working hard to create a fully functioning childcare management tool that will work for both early learning and childcare providers and children's activity providers.

The tool, known as Caerus [care-us], is a platform that helps parents find, book and pay childcare at times, and in locations, that suit them.

It helps providers to advertise their services and gives them access to a fully functioning childcare management system, that will help them manage their setting and deliver flexible childcare model, if they choose to, for free.

Caerus also collects real time data on search specifications, the data will give providers important insight into how many people have viewed their services, how many times they appeared in searches, top search terms and the specific services families are seeking helping them to match supply to demand and therefore helping them make informed decisions on business growth.

Thanks to funding from The Hunter Foundation and Scottish Government Caerus is free to use for both parents and providers.
