### Agenda item 4

4a.) Children and Families

#### 4a.1) Attainment and Education

Lois Drake / Mark Ballard, NDCS Scotland, spoke to the paper circulated.

Lois Drake spoke on Attainment. The figures are stark. NDCS Scotland will be leading a campaign. It was noted that there were no specific figures on dual sensory loss. Also, it raised issues regarding Mental Health for young people. We will share the report from Dumfries and Galloway Hard of Hearing Group (DGHHG).

#### **Actions:**

- 1.) Understand that the National Audiology Review may or may not address education as part of its scope. We must ensure that the impact of the Review improves attainment and that strategy going forward is more joined up. This may also link to the next iteration of the See Hear Strategy.
- 2.) Share the Dumfries and Galloway Hard of Hearing Group Report.

#### 4a.2) Paediatric Audiology

Mark Ballard, NDCS Scotland, covered key points:

Paediatrics will be part of the scope of the National Audiology Review. Currently, NDCS Scotland is concerned there may be some deaf children who have still been missed. We know NHS Lothian has been working hard to identify the children who have been missed; there may be children who have deafness and other complex needs where their deafness has not been fully identified, and we are doing some publicity to encourage teachers, professionals, parents with any concerns about a child's hearing to go to NHS Lothian or contact NDCS Scotland as the initial diagnosis may not be correct. We have reached professionals and are doing social media work to ensure no child is missed.

Also, the national audiology review group has been established, and Professor Jacqueline Taylor has been appointed chair. Letters have gone out inviting stakeholders to be members of the core group or a broader reference group. NDCS Scotland shared its thoughts on what the review needs to cover, and the Cross Party Group on Deafness seemed to be in agreement with those, so we took them to Professor Jacqueline Taylor for an initial meeting, and she welcomed them. The big issue we raised was reminding her the review came about because of parents who were concerned their children were not properly

diagnosed. They raised it with the health board and got nowhere, so they brought it to NDCS Scotland and worked with them to take it to the ombudsman. It was agreed the views of parents are central, and the scope of the review is important.

Please see the briefing paper prepared. Clearly, there is a lack of definition that can clear expectations of services and supports. There was a lot of support expressed for a more strategic approach to deafblindness and dual sensory loss. Mental Health was also raised as a major issue.

Gillian Heavie gave a brief overview. Susan Shippey is on secondment from Edinburgh Health and Social Care Partnership and will be working on the See Hear Strategy. Janis pinched one of my slides when she said that because we want the involvement of people with an interest. The strategy was launched in 2014, and the review means we have time until 2024 to publish a revised and refreshed version. We have an opportunity here to have members involved and look at language. I have introduced it as See Hear sensory impairment strategy, and I know that language is not entirely welcomed. We should say sensory loss. There is a chance to talk about what works and what does not, what needs to be taken out and what needs to be added for the next ten years. It is Susan's second day. We have been working on planning what the review should look like, and engagement is a big part of that. Derek Todd will create a list of people and organisations seeking to be involved in the See Hear Strategy Review discussions.
