Approval of new members and minutes

Jenny Miller was approved as a new member of the CPG on Disability

Tina Yu proposed the minutes and Linda Bamford seconded. The minutes from the previous meeting on 1 February 2022 were approved.

Annual General Meeting - Business

The membership was asked if there were any nominations for convenor. There were none and the membership agreed that Jeremy Balfour MSP should be re-elected as Convenor.

Jeremy Balfour explained that Disability Equality Scotland had been carrying out the secretariat function for the past year and asked the membership if there were any other organisation or individual who wished to put their name forward. There were none and Disability Equality Scotland was re-elected as secretariat.

Mike Harrison was re-elected as treasurer.

AGM business was concluded.

Matters Arising

Disability Commissioner - Jeremy Balfour spoke about the proposed bill for a disability commissioner in Scotland and asked the membership to engage with the current consultation.

Disabled Political Representation - Jeremy Balfour talked about the improving disabled political representation paper and stated that he is hosting a webinar on disabled representation for commonwealth countries.

MND Scotland Presentation - Colette McDiarmid and Gabrielle King from MND Scotland delivered a presentation about the work they're doing and invited some of their members to discuss how MND has affected them. Lesley Campbell spoke about the difficulty of making adaptations to her house for her husband and felt the bureaucracy was unnecessary and it was often too late by the time adaptations could be made.

MND Scotland asked that each MSP makes their local council aware of the disease and the impact that a diagnosis has on the family. MND Scotland asked that councils understand that MND patients need to plan far into the future so that their environment doesn't disabled them any further.

Film suggestion – Pam Duncan-Glancy MSP recommended the film "Then Barbera Met Alan" with the membership and that it is available to watch on the iPlayer.
