Planning (Scotland) Bill – Printing changes to the Bill As Amended at Stage 2 (SP Bill 23A) Session 5, 2018

Printing changes are changes to the text of a Bill for which amendments are not considered necessary, or which, relating to non-legislative text, cannot be made by amendment. Printing changes will not be made that would alter the legal effect of the Bill. Clerks are responsible for making a judgement in each case as to whether a printing change is appropriate. Further explanation of printing changes can be found in the <u>Guidance on Public Bills</u>, paragraphs 4.45-4.47.

This document outlines the printing changes that have been made in preparing the Planning (Scotland) Bill As Amended at Stage 2.
