- (1) Each responsible body must, as soon as practicable after the end of each financial year (subject to subsection (2)), prepare and publish a report setting out the total cost to it in that financial year of delivering the functions conferred on it by—
 - (a) in the case of a local authority or an education provider—
 - (i) section 1 or, as the case may be, 5, and
 - (ii) section 7,
 - (b) in the case of a specified public service body, sections 6 and 7.
- (2) Each responsible body must prepare and publish a report under subsection (1) for each of the three financial years beginning with the first financial year that begins after the day on which—
 - (a) in the case of a local authority or an education provider, section 1 or, as the case may be, section 5 comes into force,
 - (b) in the case of a specified public service body, the body (or class of bodies to which the body belongs) is specified in regulations under section 6.>
